

INTERPHEX 2017 Passport Program Sweepstakes Official Rules

1. HOW TO ENTER:

(a) When you register at Attendee Registration (located in Crystal Palace of the Jacob K. Javits Convention Center) for the *INTERPHEX 2017* (the "Show"), you will receive a list of Show exhibitors participating in the INTERPHEX 2017 Passport Program. To enter the sweepstakes (the "Sweepstakes"), (i) go to participating Show exhibitors and have your badge scanned and passport stamped (passport stampers will be available at each participating exhibitor's booth), and (ii) fill out your name, company name, email, and daytime phone number and deposit the completed stamped entry card in the designated raffle box at any of the Show Information Desks located throughout the Show floor by 12:00PM EST on Thursday, March 23, 2017. **Please Note: Each INTERPHEX exhibitor has the right to refuse to stamp your passport.** The Sweepstakes period begins at 10:00AM EST on Tuesday, March 21, 2017 and ends on Thursday, March 23, 2017 at 12:00PM EST. Limit one entry per person. Sponsor is not responsible for lost, misdirected, illegible, mistranscribed or late entries.

(b) NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. Alternatively, to enter, you should send a 3" by 5" postcard, postmarked by March 20, 2017 with your name, address, and daytime phone number to: *INTERPHEX 2017 Passport Program Sweepstakes, Reed Exhibitions, 383 Main Avenue, Norwalk, CT 06851, Attn: Casey Pennella*. All entries become the property of Reed Exhibitions and will not be acknowledged or returned. Incomplete entries will be considered invalid and ineligible to win. There are no additional prizes. Prizes will be awarded based on the number of participating exhibitors in the INTERPHEX Passport Program. Each participating exhibitor must submit one prize with a value of up to \$250 USD. Please be aware that there may be a tax liability in accepting a prize (See Rule No. 5 below).

(b) A total of 6 winners will be selected in a random drawing by the Sponsor. The drawing shall be held at approximately 1:00 PM EST on Thursday, March 23, 2017. The Sponsor will announce the winners on Thursday, March 23, 2017 via social media channels. Winners need not be present to win. Winners will be notified via e-mail or phone by Thursday, March 23, 2017. Odds of winning are dependent upon the total number of eligible entries received. Please be aware there may be a tax liability in accepting a prize (See Rule No. 5 below).
